1. The school has not submitted the compliance against Board's letter bearing no. CBSE/AFF/1130488/EX-00322-1819/2017/1327073 dated 28.11.2017. (copy enclosed) Therefore, the school is required to submit the same along with supportive documentary evidences.
2. The school is required to submit certificate from the State Education Department to the effect that the school is paying salary to its staff as per norms of the State Government.
3. The school is required to furnish renewed Health & Sanitary, Safe-Drinking Water, Building Safety, Fire Safety and Transport Safety Certificates issued by the competent authorities/concerned department.
4. The school is required to submit Recognition Certificate for running classes from VI to VIII from the Competent Authority of the concerned State Government.


